

Table shows an estimate of the palm import in the following countries as at the end of 2016




The Company's service routes in the area of palm production and import of the world




The Growth of Palm Oil Industrial


Producer of palm oil

Palm Oil Importer (Figures show the quantity of the import of palm oil)













Nature of Business - Tank Trucks Service




Significant of Total Revenue






Revenue Structure from Transportation Service













Significant Gross Profit Margin








